Act-1961 does not confer any exemption U/s-10 or any donations to the Institutions eligible for deduction U/s-80G of the Income-tax Act, 1961. Separate application with accounts have to be filed before the respective Commissioner of Income-tax who is having jurisdiction to seek benefit U/s-80G of the Income Tax Act, 1961.

4. The Assessing Officer is at liberty to determine the income of the Trust with reference to Secs.11, 12 & 13 of the I.T. Act-1961, and also verify the genuineness of the Trust/Institution.
